1. India has received a loan from the Asian Development Bank (ADB) towards the cost of Rajasthan Urban Sector Development Investment Program (RUSDIP). Part of the proceeds of this loan will be used for payments under the contracts named above. Bidding is open to bidders from eligible source countries of the ADB.
2. The Project Director, RUIDP on behalf of Local Self Government Department under Urban Development Department of the State of Rajasthan now invites sealed bids from experienced & eligible bidders based on following post-qualification criteria for the construction and completion of following work at Jaisalmer investment program town on Turnkey Basis:

3. **The brief description of the work are as follows:-**

- Raw water pumping Station with 3 Nos. V.T. pumps, 6.6 KV Electric motor and related electrical & mechanical equipments and instruments.
- Surge protection system.
- 600 mm pipe line 57100 m with required air valves, butterfly valves scour valves etc.

4. **Major qualification criteria are as follows:**

A. **Pending Litigation:**

The Employer shall consider the litigation record of Bidders to verify their qualifications. Bidders shall submit documentary evidence of all claims, arbitrations, or other litigation, pending or already resolved, with a possible impact of more than 50% of net worth. Those having litigation affecting 50% of net worth are to be rejected. If necessary the Employer will make enquiries from the Bidder's past Employers to confirm the correctness of the information provided in the Bidder's bids.
