INVITATION FOR SHORT TERM BIDS (ADB LOAN No. 1647- IND)

1. This Invitation for Bid follows the General Procurement Notice for this project that appeared in the “ADB Business opportunities”, issue Volume 24/No.4 of April, 2002
2. **India** has received a loan from the Asian Development Bank (ADB) towards the cost of **Rajasthan Urban Infrastructure Development Project (RUIDP)**, and it intends to apply a part of the proceeds of this loan to eligible payment under these contracts.
3. The Project Director invites bids from experienced & eligible bidders based on post-qualification criteria for the construction and completion of following work at Bikaner city:

4. Interested bidders may obtain further information regarding bidding documents, from office of Project Director, Rajasthan Urban Infrastructure Development Project, AVS Building, Jawahar Circle, JLN Marg, Malviya Nagar, Jaipur -302017.
5. A complete set of bidding document for the package (in duplicate) may be purchased by interested eligible bidders on submission of a written application to the above office, and on payment of a non-refundable fee of Rs.1500/= (Indian Rupees One Thousand five hundred only), be in the form of Bank Draft in favour of the Project Director, RUIDP, Jaipur, during normal office hours on all working days **up to 22.6.2007**. Those bidders who desire to receive the bid documents by post shall have to pay Rs. 250/= per document (in duplicate) extra.
6. All bids must be accompanied by a bid security, as mentioned above and sealed bids must be delivered to Office of the Project Director on any working day but up to **15:00 hours** on **23.6.2007**. Bid securities shall be in the form of Bank Draft, Pay Order or Unconditional Bank Guarantee from any Scheduled Bank in India in favour of the Project Director, Rajasthan Urban Infrastructure Development Project, Jaipur.
7. Technical proposal shall be opened in the presence of the Bidders’ representatives who choose to attend at 16:00 hrs on the same day, and at the same place. At the end of evaluation of Technical proposals, RUIDP will invite bidders, who have submitted substantively responsive Technical proposals and who have been determined as being qualified for award, to attend the opening of the price proposals at the date and time to be determined.
8. In the event of the specified dates being declared a holiday for the RUIDP, the bids shall be received and opened at the same time and place on the next working day.
9. The Project Director will not be responsible for any costs or expenses incurred by Bidders in connection with preparation or delivery of Bids, or loss of any documents during transit.

10. Bids delivered after the time and date noted above will be declared "LATE", and will not be accepted.
11. Project Director reserves the right to accept any bid, or reject any or all bids, without assigning any reason thereof and without incurring any liability, whatsoever in favour of the Bidder or Bidders.

Special Terms and Conditions

1. Preference would be given to Contractors, who own their T & P and Machineries to execute the work. The proof of ownership shall have to be enclosed in Envelop 1.
2. The bidders must have experience for carrying out at least one work of similar nature successfully for the quantity mentioned in bid document. The certificates of this effect from competent authority shall have to be enclosed in Envelop 1.
3. The bidders shall be required to submit copies of latest clearance certificates from Income Tax Department and Sales Tax Department in Envelop 1.
4. The bidders should have an average annual turnover of at least Rs. 50 Lac for the last three years. The bidders shall be required to submit attested copies of latest audited report of firm showing annual turnover in Envelop 1.
