A copy of Contract Agreement duly signed by the undersigned and your authorized representative for the work of Supply and Delivery of Bin Carrier (capacity 1.1 cum.) Auto Rickshaw 9 Nos. under contract package RUSDIP/TR-I/ALW-JHL-JHP-JSL/SW/02(Lot-1), is enclosed herewith for the contract price for above work is **Rs.37,94,133.00** (Rupees Thirty Seven Lacs Ninety Four Thousand One Hundred Thirty Three only) inclusive of Rs 3,25,105 estimated sales tax and Rs 50,000 provisional sum but excluding Excise Duty.

1. The supply of equipments under this work order shall be completed within 9 months period. Accordingly date of commencement of work shall be 15.10.2008 and stipulated date of completion shall be 14.09.2009.The contract completion date for this contract is 14.09.2009.
2. The supply schedule and tentative date for readiness of equipments for inspection should be conveyed to this office immediately.
3. The equipments shall be supplied in following City Corporation/IPIU Office.

4. The material is to be got inspected at factory by the 3rd party inspecting agency as authorized by RUIDP. The material shall be dispatched only after inspection and acceptance by 3rd party inspecting agency/RUIDP.
5. Payment conditions shall be as under :-
- (i) Payment for Chassis, if desired by the supplier will be made as advance payment to the supplier against the Proforma invoice of chassis manufacturer/ dealer in the name of RUIDP. This payment shall be made by RUIDP to supplier on submission of the unconditional Bank Guarantee of equal amount in the name of Project Director, RUIDP valid for the period of 9 months extendable till the delivery of vehicles to their final destination. The chassis shall be property of RUIDP but the same shall be delivered to the supplier for fabrication.
 - (ii) The initial payment of eighty percent (80%) of Contract Price shall be made within 28 days only after receipt of material and upon submission of documents specified in SCC clause 12.1, at concerned city and after inspection and acceptance of material by EE, IPIU. The advance payment made against chassis shall be deducted from this payment.
 - (iii) Balance twenty (20) percent of the Contract Price of the Goods received shall be paid within twenty-eight (28) days of receipt of the Goods after inspection and requisite training and upon submission of a claim supported by the acceptance certificate issued by the Purchaser and after completion of contract in all respect..
 - (iv) The payment authority is Project Director, RUIDP, Jaipur.
6. The final registration and insurance of the equipments shall be arranged in the name of the respective local body before final acceptance by the EE, IPIU Concerned. The Basic Comprehensive insurance covering theft, fire, riots and road accidents etc. for one year shall also be provided by the supplier.

7. The equipments should be conforming to the RUIDP equipment specifications.
8. Other terms and conditions of the Contract shall be as per the Contract Agreement.


